For Immediate Release: September 27, 2025

Fatal Traffic Crash

Bloomington, IL - On Saturday, September 20, 2025, at approximately 5:15 a.m., Bloomington police officers responded to the 1000 block of Hinshaw Avenue for a report of a motor vehicle crash with injuries. The Bloomington Fire Department was also dispatched to the scene.

Upon arrival, officers secured the crash scene and began their investigation, while paramedics provided medical care to the passenger. Due to the severity of the incident, the McLean County Accident Reconstruction Team was requested.

The front seat passenger, an adult male, was transported to a local hospital with potentially life-threatening injuries. Other occupants of the vehicle sustained injuries not considered to be life-threatening.

Preliminary investigation indicates the vehicle was traveling northbound on Hinshaw Avenue when, for unknown reasons, it left the roadway and struck a utility pole.

McLean County Coroner Dr. Kathleen Yoder is releasing the following information regarding the crash:

Pronounced deceased at Carle BroMenn Medical Center on September 24, 2025 at 9:24 a.m. was Travis Floyd, age 22, of Bloomington, Illinois.

Preliminary autopsy opinion indicates that Mr. Floyd died of blunt head injuries due to an automobile striking a fixed object, reportedly sustained as a front seat passenger.

The circumstances behind this incident are still pending investigation by the Bloomington Police Department, the McLean County Accident Reconstruction Team, and the McLean County Coroner's Office. Anyone with information should contact the Bloomington Police Department at 309-820-8888.
